Subject: Grant in aid for engagement of Block Level Facilitators (BLFs) under the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram for Minority Concentration Areas (MCAs) to the State of **Uttarakhand**

Sir,

I am directed to convey the sanction of the President for release of total amount of **Rs.15,00,000 /-** (**Rupees Fifteen Lakh Only**) to the Govt. of Uttarakhand as remuneration for Block Level Facilitators (BLFs) to be engaged by State of Uttarakhand for Minority Concentration Blocks of PMJVK on contract basis as per details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Uttarakhand through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No. 69, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 - General- (Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 64- Pradhan Mantri Jan Vikas Karyakram for minorities, 64.00.31 Grant in Aid General for the year 2020-21.

3. Utilization Certificate for this grant should be submitted by the State in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guidelines for Pradhan Mantri Jan Vikas Karyakram.

4. The State shall submit a list of the BLFs to the Ministry stating their qualification, date of appointment, email ID, mobile number and the name of block where they have been deployed.

5. Funds should be released by the State Govt. to the BLFs either directly through bank transaction to the individual bank accounts or in case the BLFs are engaged through an Agency, it may be ensured that the payments from the agency to the BLFs are made only through bank transactions to the individual accounts. 


