
In continuation to this Ministry's sanction letter of even number dated 29.05.2020, I am directed to convey the sanction of the President for release of total amount of **Rs.3,17,10,000 /-** (**Rupees Three Crore Seventeen Lakh Ten Thousand Only**) to the Govt. of West Bengal for engagement of Block Level Facilitators (BLFs) as per details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of West bengal through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No. 69, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 - General- (Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 64- Pradhan Mantri Jan Vikas Karyakram for minorities, 64.00.31 Grant in Aid General for the year 2020-21.

3. Utilization Certificate for this grant should be submitted by the State in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guidelines for Pradhan Mantri Jan Vikas Karyakram.

4. The State shall submit a list of the BLFs to the Ministry stating their qualification, date of appointment, email ID, mobile number and the name of block where they have been deployed.

5. Funds should be released by the State Govt. to the BLFs either directly through bank transaction to the individual bank accounts or in case the BLFs are engaged through an Agency, it may be ensured that the payments from the agency to the

BLFs are made only through bank transactions to the individual accounts. As per the directions of Govt. of India, Ministry of Finance, parking of funds at any level is strictly prohibited.

6. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at **Annexure-II**.





Annexure-II

Utilization of the above mentioned amount by the grantee is subject to the following terms and conditions:

- i. Grantee will maintain a separate account of the funds released by this Ministry under this scheme/programme.
 - ii. Funds should be released by the State Govt. to the BLFs either directly to the individual bank accounts or in case the BLFs are engaged through an Agency, it may be ensured by the State Govt. that the payments from the agency to the BLFs are made only through bank transactions to the individual accounts.
 - iii. The expenditure incurred by the grantee shall be open for inspection by the sanctioning authority/ Comptroller & Auditor General of India/Internal Audit by the Chief Controller of Accounts of the Ministry of Minority Affairs.
 - iv. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
 - v. Grantee shall not divert any part of the grant to any other activities.
 - vi. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
 - vii. Grantee shall endeavor to achieve the quantified and qualitative targets.
- viii. Contact details of each BLF is to be shared with Ministry.
